The major focus for the Foundation of the Cairn Terrier Club of America (CTCA) for 2006 has continued to be health education and health related research. Currently, the Foundation is supporting three research activities in the following areas: Cranio-Mandibular Osteopathy (CMO), Portal Systemic Shunt (PSS), and Ocular Melanosis (OM). Progress reports regarding each of these projects are posted on the CTCA and Foundation websites and are included in the annual report from the Health Related Concerns Committee of the CTCA as well as the recent newsletter distributed by the Foundation. The website for the Foundation was just developed this year with the assistance of Brad LaBroad and Kevin Durkin. In addition to progress reports on research activities additional information about the Foundation is included such as current financial reports and donor lists for example. We are eagerly awaiting the report from the health survey that was distributed by the Health Related Concerns Committee to provide us with an update on genetic problems and health concerns regarding our breed.

The Foundation has a new Vice Chair, Pam McDonald, and a new Treasurer, Dave Tuttle. We want to express our deepest gratitude and appreciation to Dwight Hutchinson for his excellent work as our Treasurer during the past few years. Attached is the current financial statement for the Foundation.
